# **Value Line High Dividend Portfolio**

**Investment Objective:** Capital Appreciation and Income

## **Investment Approach**

Candidate companies have demonstrated a history of distributing profits to shareholders through consistent or higher dividend payments over eight consecutive quarters. At selection, stocks must also have a Value Line® Timeliness<sup>TM</sup> Rank and Value Line® Safety<sup>TM</sup> Rank of 1, 2 or 3; a stock price of at least \$5; and market capitalization of at least \$2 billion; in addition to other proprietary criteria. The Portfolio will consist of approximately 50 positions. Companies are selected each quarter with a monthly review for Rank changes. Portfolio weights are rebalanced annually.



# **Value Line Multi-Cap Global Portfolio**

**Investment Objective:** Capital Appreciation

### **Investment Approach**

All Value Line Ranked stocks that have significant revenues generated from activities outside of the U.S. are eligible for inclusion in the Value Line Multi-Cap Global Portfolio Composite. Approximately 200 companies meet the Composite criteria out of the 1700 Value Line universe. U.S.-listed securities within the portfolio are selected from stocks with a higher Timeliness™ Rank and significant foreign-sourced revenue. The Portfolio will consist of approximately 50 positions.

**Investment Objective:** Long-Term Capital Appreciation

### **Investment Approach**

Candidate companies must have a higher Value Line® Timeliness<sup>TM</sup> Rank, a market capitalization of at least \$1 billion on any selection date and meet additional performance criteria as well. The Portfolio will consist of approximately 50 positions which are related to businesses involved with infrastructure investment (physical, non-financial).
